#### **S114.1 LOCAL ROADS AND COMMUNITY INFRASTRUCTURE PROGRAM**

#### Purpose

This report seeks Councils consideration to focusing Commonwealth Local Roads and Community Infrastructure (LRCI) Grant Program funds towards implementation of the Sturt Reserve Master Plan Implementation, in particular, the Stage 1 History & Tourism Precinct Program intended to be delivered in 2020/21.

#### Background

A letter received from the Hon Michael McCormack MP, to Mayor Brenton Lewis on 3<sup>rd</sup> July 2020 included details regarding the Commonwealth, Local Roads and Community Infrastructure (LRCI) Program. Specifically, the letter (**Attached**), included an offer for a Grant of \$571,938.00 (Ex GST), to undertake Local Roads or Community Infrastructure works, for a discrete project or to complement a larger program of works.

The LRCI Program aims to assist a community-led recovery from COVID-19 by supporting local jobs, firms and procurement, through (where possible) using local businesses and workforces to deliver programs.

To accept the offer from the Commonwealth, Council must submit a proposal for the grant to the Commonwealth by 31 July 2020.

If the Commonwealth accepts Councils proposal, the funds associated with the program are required to be expended by 30 June 2021, whether they are part of a discrete project or part of a larger program.

Accordingly, the Council must consider a program to which these funds be allocated and submit an application for same by 31 July 2020.

#### Proposal

As it relates to the Sturt Reserve Master Plan Implementation, at its Meeting on 13 July 2020, Council resolved (in part), that;

"Council note Administration will work towards finalisation of the Sturt Reserve Design Development with specific emphasis placed on development of the scope for works for;

- a. Determining the delivery of a Boat Ramp in Sturt Reserve or otherwise;
- b. Developing the Scope of Works and funding model for Stage 1 delivery of the History and Tourism Precinct, focussed on Wharf works to facilitate vessel mooring, and embellishment landscaping works surrounding the War Memorial";

It is recommended that Council applies the LRCI, grant funds of \$571,938.00 (Ex GST), towards delivery of Stage 1 of the History and Tourism Precinct (above), with the focus of the LRCI funds being for landscaping works surrounding the War Memorial.

While the exact scope of the landscaping works surrounding the War Memorial is yet to be determined (but imminent in the coming months), landscaping is considered to be a deliverable item within the timeframes nominated by the Commonwealth for their LRCI Program. It is noted that landscaping improvements are eligible items under Clause 5.6 of the Commonwealth Agreement.

#### **Financial Implications**

Council adopted a program budget for Sturt Reserve, as part of its 2020/21 Annual Business Plan and Budget; viz; Headline Project – Sturt Reserve Master Plan – Historic & Tourism Precinct.

The allocated program budget is \$3,109,000, including \$1,710,000 Council funds, and \$1,399,000 as expected income from other sources.

Anticipated funding via BBRF Round 4, (for the \$1,399,000 component) has not been forthcoming, accordingly, to continue delivery of the headline project, it is recommended that the Commonwealth Grant of \$571,938.00 (Ex GST), be directed towards delivery of Stage 1 of the History and Tourism Precinct with the focus of the LRCI funds being for landscaping works surrounding the War Memorial.

#### Risk

The risks associated with delivery of the LRCI Program are;

- Any required conditions of Development Consent cannot be met
- The discovery of Cultural Heritage items
- LRCI Grant funding conditions and activities and timing cannot be met
- Latent conditions during works
- Independent cost analysis is incorrect
- The program is not delivered on time/budget
- Tender exceeds budget
- Construction contractor defaults
- End of time delay cost exceed budget
- Design and Construction is delayed and compromised by the requirements /controls required associated with the Former Landfill Site at Sturt Reserve

#### WHS

There are no new WHS implications as a result of this report.

#### **Asset Management**

Subject to LRCI grant funding, works associated with the History and Tourism Precinct will be a combination of renewal and replacement and enhancement works, thus impacting/increasing the asset base.

Operational maintenance costs and levels of service for maintenance will be reviewed concurrently with delivery, however, it is envisaged with the up-lift of open space resources, maintenance of the Recreation Precinct will be contained within operating budgets.



#### Implementation Strategy

Subject to LRCI grant funding being allocated, any program works associated with LRCI funding would need to be delivered by 30 June 2021.

#### Communication Strategy

Once Sturt Reserve, History and Tourism Precinct – Stage 1 works are defined, a communication plan would be established for communication to key stakeholders and the general public

#### **Strategic Plan**

Goal 1 - Valued Environment 1.3 - A City Geared for Growth

#### Recommendation

- 1. That item number \$114.1 on the Special Council agenda of 27 July 2020 be received and noted.
- 2. The Chief Executive Officer be authorised to prepared a submission for the Commonwealth Local Roads and Community Infrastructure of \$571,938.00 (Ex GST), for submission by 31 July 2020, with the focus of the submission being directed towards delivery of Stage 1 of the History and Tourism Precinct with the application of the LRCI funds being for landscaping works surrounding the War Memorial.
